6. INTRODUCTION OF MEMBERS:

Dr.Sumohana S. Channappayya - Dean R&D, IIT Hyderabad introduced the Chairman **Prof. B. S. Murty-** Director IIT Hyderabad and **Dr K R Murali Mohan-** Mission Director, NM-ICPS and Scientist-G & Head, ICPS Division, DST.

The Mission Director NM-ICPS, DST **Dr. K R Murali Mohan** informed the board about National Mission on Interdisciplinary Cyber Physical Systems (NM-ICPS) project. He explained the details about the overall philosophy of the Mission, technology, strategy and overall Mission objectives.

Dr. Murali also informed that the Mission implementation would create a foundation and a seamless ecosystem from education, human resource, R&D, technology development, innovation to commercialization. 9. PRESENTATION ON TIH AT IITH:

Initiatives taken so far which is presented:

Prof. Rajalakshmi Pachamuthu- Project Director/Member Secretary informed the board, that DST has provided the guidelines for the operations of Hub Governing Body. She has further explained TiHAN - Organization and Operation structure will be classified in different wings such as R&D Wing, Academic Wing, Industry Relations Management Wing, Technology Business Incubator Wing and Finance & Administration Wing.

- NMICPS Technology Innovation Hub On Autonomous Navigation Foundation TiHAN Foundation (Section 8 Company) is incorporated
- Bank Account is created in Nationalised Bank with interest bearing feature
- HRD: 2 year Inter Disciplinary M.Tech program in Smart Mobility is started in Aug 2020, PhD students, Post Docs, Research Staffs recruitments going on
- R&D:
 - o Testbed on Autonomous Navigation (Aerial/Terrestrial) is proposed to be setup at IITH. Testbed with Mechanical Integration Facility, Test circuits/tracks, and required Equipments is planned. Area to setup testbed is identified in the IITH campus. Master Plan and Design is in progress, which is presented.
 - Academic institutions, Government Labs and Industry (Indian and International) have already expressed interest to collaborate with the Hub in different sub-domains of the technology vertical of Autonomous navigation and data acquisition systems.
 - Call for research proposals for academic and labs is proposed. With industry, R&D collaborations on cost sharing basis, consultancy and consortium mode is proposed with appropriate MoU/NDA.
